In 2002, The Trust joined forces with The Faramir Trust, a sister sailing charity, to reduce costs and to provide a wider geographical basis of operation. The Trust is now a Charitable Company Limited by Guarantee and anyone who wishes to support the aims of the Trust can become a Member.

We are keen to attract as many people as possible to become Members.
